**Revised 2009 Chemtura Entities CDS Protocol and 2009 Rouse CDS Protocol -  
Adherence**

The purpose of this letter is to confirm our adherence to:

We hereby appoint ISDA as our agent for the limited purposes of the Protocol and accordingly we waive, and hereby release ISDA from, any rights, claims, actions or causes of action whatsoever (whether in contract, tort or otherwise) arising out of, or in any way relating to, this Adherence Letter or our adherence to the Protocol or any actions contemplated as being required by ISDA.
