Additional Provisions for Fixed Recovery CDS Transactions¹ (September 24, 2010)

1. Buyer and Seller agree that in the event of any inconsistency between these Fixed Recovery CDS Provisions and any other document that is incorporated into a Confirmation that incorporates these Fixed Recovery CDS Provisions, these Fixed Recovery CDS Provisions will govern.

2. Settlement Terms:

Settlement Method: Cash Settlement

Fallback Settlement Method: Not applicable

- 3. Section 6.5 <u>10.1 (Settlement Suspension)</u> shall be amended by deleting the words "Physical Settlement Date or, to the extent applicable, a Valuation Date" and replacing them with the words "Cash Settlement Date".
- 4. Section 7.2 (*Cash Settlement Date*) shall be deleted and replaced as follows:

"Section 7.2. Cash Settlement Date. "Cash Settlement Date" means, subject to Section 6.510.1 (Settlement Suspension), either:

- (a) the date that is the number of Business Days specified in the related Confirmation (or, if a number of Business Days is not so specified, five Business Days) following either:
 - (i) if an Event Determination Date is determined pursuant to Section 14.81(a)(i), the third Business Day following such Event Determination Date; provided that no Credit Event Resolution Request Date occurs on or before such third Business Day;
 - (ii) subject to Section 7.2(a)(i), if ISDA publicly announces that the relevant Credit Derivatives Determinations Committee has Resolved not to determine the matters described in Sections 1.24(a) and (b)a DC Credit Event Question Dismissal occurs, the later of (A) the day on which all Conditions to Settlement are satisfied Event Determination Date and (B) the date of such announcementDC Credit Event Question Dismissal;
 - (iii) subject to Section 7.2(b), if the Conditions to Settlement are satisfied an Event Determination Date occurs and an Auction Cancellation Date

The "Additional Provisions for Fixed Recovery CDS Transactions (September 24, 2010)" (the "Fixed Recovery CDS Provisions") may be incorporated into a relevant confirmation (including in electronic form) by wording in the document indicating that the Fixed Recovery CDS Provisions are so incorporated by reference therein.

The Fixed Recovery CDS Provisions are intended for use with the Credit Derivatives Physical Settlement Matrix published by ISDA.

occurs or one or more Parallel Auction Cancellation Dates occur, the last such Auction Cancellation Date or Parallel Auction Cancellation Date;

- (iv) subject to Section 7.2(a)(i), if the relevant Credit Event in respect of which the Conditions to Settlement are satisfied Event Determination Date occurred is not an M(M)R Restructuring and a No Auction Announcement Date described in clause (a) or (c) of Section 12.12 6.11 (No Auction Announcement Date) occurs, such No Auction Announcement Date; or
- (v) subject to Section 7.2(a)(i), if the relevant Credit Event in respect of which the Conditions to Settlement are satisfied is a Event Determination occurred is an M(M)R Restructuring and a No Auction Announcement Date described in clause (a) or (c) of Section 12.12 6.11 (No Auction Announcement Date) occurs, the Exercise Cut-off Date; or
- (b) if the Conditions to Settlement are satisfied an Event Determination Date occurs and an Auction Settlement Date or a Parallel Auction Settlement Date occurs, the first such Auction Settlement Date or Parallel Auction Settlement Date to occur.

The Cash Settlement Date shall be the Termination Date."

- 5. Section 7.4 (*Final Price*) shall be deleted and replaced as follows:
- "Section 7.4. Final Price. "Final Price" means the percentage specified as such in the related Confirmation."
- 6. Section 7.8 (*Valuation Date*) shall be deleted, and, for the avoidance of doubt, a Valuation Date will not occur in respect of the relevant Credit Derivative Transaction.
- 7. Section 12.9 6.8 (*Transaction Auction Settlement Terms*) and Section 12.10 6.9 (*Parallel Auction Settlement Terms*) shall be amended by deleting the words "the relevant Credit Derivative Transaction" and the words "such Credit Derivative Transaction" and replacing them in each case with the words "an Equivalent Auction-Settled Transaction".
- 8. **Equivalent Auction-Settled Transaction.** "Equivalent Auction-Settled Transaction" means, with respect to a Credit Derivative Transaction the documentation for which incorporates both the 2005 Matrix Supplement and the Fixed Recovery CDS Provisions (a "Fixed Recovery CDS Transaction"), a hypothetical Credit Derivative Transaction (a) on the same terms as such Fixed Recovery CDS Transaction, except that the Fixed Recovery CDS Provisions shall be deemed not to be incorporated into the documentation therefor, and (b) for which an Event Determination Date will be deemed to have occurred if an Event Determination Date has occurred for purposes of such Fixed Recovery CDS Transaction."
