2009 Nortel Entities CDS Protocol - Adherence

The purpose of this letter is to confirm our adherence to the 2009 Nortel Entities CDS Protocol, as published by the International Swaps and Derivatives Association, Inc. on February 2, 2009 (the "Protocol"). This letter constitutes an "Adherence Letter" as referred to in the Protocol.
