Trade Data Reporting

On March 24, dealer members of ISDA met with JFSA to provide the overview of the ISDA TR Paper – "Improving Regulatory Transparency of Global Derivatives Markets: Key Principles" published in late February and shared views on the relevant topics from the perspectives of those currently satisfy the mandatory trade reporting requirement to cover multiple jurisdictions.

Prior to the meeting with JFSA, ISDA conducted a comparison survey to ask its members for opinions based on the realities through norms and the level of flexibility to adapt to any future changes perceived among jurisdiction, and the information collected from the members were quoted anonymously and shared in the same discussion.

On March 31, ISDA circulated members a memo with an aim to do a survey on the topic related to the ISDA's proposal of OTC Derivatives Products Taxonomies v2.0 (UPI) published on ISDA website dated March 25, awaiting the feedback from the members during the certain public comment period.

ISDA will hold an in-person meeting with members based on the results of both surveys, in the near term.

IM Segregation Working Group

On March 6, IM Segregation Working Group meeting was held to discuss the latest version of the draft of trust account agreement as well as the presentation material summarizing the structure of the trust account agreement. The draft agreement and the presentation material will be circulated in the next Japan Collateral Committee.

Members also discussed the operational flows for segregated IM using Japanese trust account and global custodians by collateral types and the location of counterparties.
